- SUPPORT FROM MANAGEMENT AND APPROPRIATION OF THE SITE
- EASY AND PERMANENT COMMUNICATION WITH THE IIN
- AVAILABILITY OF EQUIPMENT AND ACCESS TO INTERNET



## NEGATIVE ELEMENTS

- PROBLEMS WITH THE IDENTIFICATION OF CASES
- SEEN BY PEOPLE INVOLVED AS AN ADDITIONAL TASK
- NOT EASY RESPONSE
- SKEPTICISM



# PARTICIPATION



**• THE MEDIA. IT IS IMPORTANT TO COUNT ON THE PARTICIPATION OF THE MEDIA TO FACILITATE THE SEARCH FOR AND IDENTIFICATION OF VÍCTIMS OR FAMILY MEMBERS.**

**IN EL SALVADOR: GOOD RAPPORT WITH THE MEDIA PERMITS OBTAINING FREE AND FAST COVERAGE. IF NECESSARY WRITTEN PUBLICATIONS COULD BE PAID BUT FOR THE TIME BEING WE HAVE GOOD AND FREE COVERAGE ON TOPICS RELATED TO CHILDREN.**



# INFORMATION ON CASES

## INTERNALLY

- SUPPOSED TO PROVIDE INFORMATION AS A NECESSARY MEANS TO STOP VIOLATIONS OR TO RE-ESTABLISH RIGHTS.
- MEANS USED TO REQUEST AND TO SEND INFORMATION

## EXTERNALLY

- PROCEDURES TO REQUEST INFORMATION
- AGILITY IN SOME AND SLOWNESS IN OTHERS IN PROVIDING THE INFORMATION

- RIGOR AND INSTITUTIONAL FORMALITIES TO ACT EX OFFICIO.
- LITTLE INFORMATION ON THE FAMILY



## OPPORTUNITIES

- TO GUARANTEE RESPECT FOR RIGHTS OF CHILDREN AND ADOLESCENTS
- INTER-INSTITUTIONAL COORDINATION
- IMPROVE INTERNAL PROCESSES
- HAVE APPROPRIATE INFORMATION IN ORDER TO MAKE DECISIONS

## THREATS

- SLOWNESS IN GETTING INFORMATION AND RESULTS
- LOSS OF INSTITUTIONAL CREDIBILITY
