Participants profile

The course is aimed at state and civil society operators across the systems for the protection, promotion, and fulfillment of rights, the penitentiary system, the judiciary, and other actors linked to the subject.

Objectives

- **Visualize and prioritize the specific problems of children and adolescents with adult caregivers deprived of liberty in the region.**
- **Identify potential actions of different nature that promote and protect the rights of these children and adolescents.**

Modality

Virtual, asynchronous, through the Moodle Platform. Each module will have a mandatory thematic content and evaluation activity, which the participant will be able to review and complete on days and times of their convenience, within the established deadlines. Additionally, extension contents and other non-mandatory activities will be included. Eventually, there could be synchronous activities, for which we will call in due course. It requires, on average, a dedication of 8 hours per week.

Evaluation and approval criteria

In order to pass the course, participants must complete the process, comply at least 80% of the assessment activities, and achieve a final grade of 7/10 or higher, resulting from the simple average of the grades obtained in all evaluation activities. Formal aspects of the participation and elements that give an indication of the learning process will be considered.
